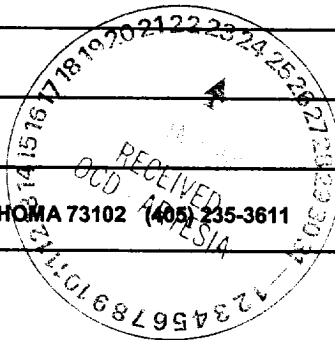

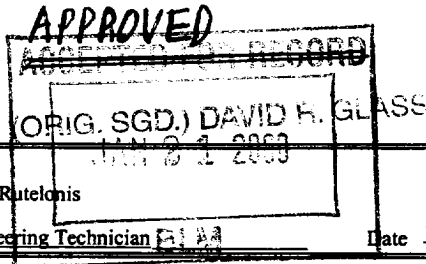

Devon Energy Corporation (Nevada) plans to reperforate & stimulate the San Andres as follows: RU PU. TOH w/ rods & pump. ND wellhead & NU BOP. TOH w/ 2-7/8" & 2-1/16" tbg. Reperforate the San Andres w/ 1 JSPF @ 1863'-2221' (18 holes). PU RBP, pkr, SN & TIH on 2-7/8" tbg. Set RBP @  $\pm 2350'$ . Set pkr above RBP & test RBP to 1000 psi. Pull pkr to  $\pm 2221'$  & spot 15% NE-FE acid across San Andres perfs @ 1863'-2221'. Set pkr @  $\pm 1700'$ . Acidize San Andres perfs @ 1863'-2221' down tbg w/ 1500 gals 15% NE-FE acid using 70 ball sealers @ max rate & pressure of 6 BPM & 4000 psi, respectively. Flush to bottom perf w/ produced wtr. Flow well down, release pkr, TOH & LD pkr. ND BOP. NU frac valve & frac down csg w/ 36,000 gal prepad + 48,000 gals linear gel + 2000# 100 mesh sd + 34,000# 20/40 Brady sd + 15,000# CRC sd. Flow well down, NU BOP, PU retrieving head. TIH, wash out sd fill, release RBP. TOH & LD RBP. Run 1-1/16" & 2-7/8" tbg, pump & rods. Pump test until production stabilizes. Production from San Andres and Glorieta-Yeso downhole commingled per NMOCD Administrative Order DHC-2330.
