Drld 7 7/8" hole and reached TD 2500' on 1/18/97 at 2130 hrs. Schlumberger ran LDT/CNL/DLL/MSFL/GR logs. Ran 60 jts 5 1/2" 15.5# J-55 LT&C csg, set at 2499'. Cemented w/150 sx lite "C" + 325 sx Class "C". Circ'd 29 sxs cmt.
