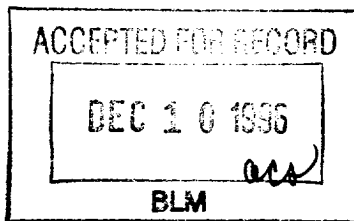

Spudded this well on 11/23/96 at 1230 hrs and drld a 12 1/4" hole to 1079'. On 11/25/96 ran 27 jts 8 5/8" 24# J-55 ST&C csg, set at 1078'. Cemented w/300 sx lite "C" + 200 sx Class "C". Circ'd 73 sxs cmt.

Drld 7 7/8" hole and reached TD 2600' on 11/27/96 at 2200 hrs. Schlumberger ran LDT/CNL/DLL/MSFL/GR logs. Ran 60 jts 5 1/2" 15.5# J-55 LT&C csg, set at 2599'. Cemented w/150 sx lite "C" + 475 sx Class "C". Circ'd 130 sxs cmt.

Released rig at 1700 hrs 11/28/96. WOCU.
