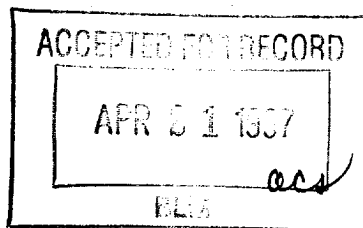

Spudded this well on 3/24/97 at 1200 hrs and drld a 12 1/4" hole to 1055'. On 3/26/97 ran 26 jts 8 5/8" 24# J-55 ST&C csg, set at 1054'. Cemented w/300 sx lite "C" + 200 sx Class "C". Circ'd 120 sxs cmt.

Drld 7 7/8" hole and reached TD 2650' on 3/29/97 at 1000 hrs. Schlumberger ran LDT/CNL/DLL/MSFL/GR logs. Ran 64 jts 5 1/2" 15.5# J-55 LT&C csg, set at 2648'. Cemented w/250 sx lite "C" + 275 sx Class "C". Circ'd 63 sxs cmt.

Released rig at 0600 hrs 3/30/97. WOCU.
