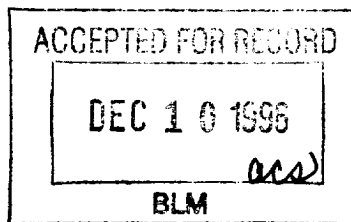

Spudded this well on 11/10/96 at 1530 hrs and drld a 12 1/4" hole to 1073'. On 11/12/96 ran 27 jts 8 5/8" 24# J-55 ST&C csg, set at 1072'. Cemented w/300 sx lite "C" + 200 sx Class "C". Circ'd 96 sxs cmt.

Drld 7 7/8" hole and reached TD 2600' on 11/15/96 at 1900 hrs. Schlumberger ran LDT/CNL/DLL/MSFL/GR logs. Ran 62 jts 5 1/2" 15.5# J-55 LT&C csg, set at 2599'. Cemented w/150 sx lite "C" + 375 sx Class "C". Circ'd 110 sxs cmt.
