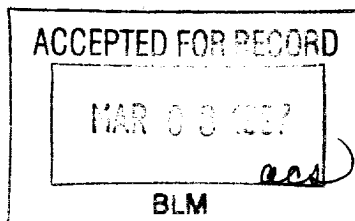

Spudded this well on 2/1/97 at 1400 hrs and drld a 12 1/4" hole to 1057'. On 10/25/96 ran 26 jts 8 5/8" 24# J-55 ST&C csg, set at 1056'. Cemented w/300 sx lite "C" + 200 sx Class "C". Circ'd 87 sxs cmt.

Drld 7 7/8" hole and reached TD 2500' on 2/7/97 at 1200 hrs. Schlumberger ran LDT/CNL/DLL/MSFL/GR logs. Ran 62 jts 5 1/2" 15.5# J-55 LT&C csg, set at 2499'. Cemented w/150 sx lite "C" + 450 sx Class "C". Circ'd 61 sxs cmt.

Released rig at 1100 hrs 2/9/97. WOCU.
