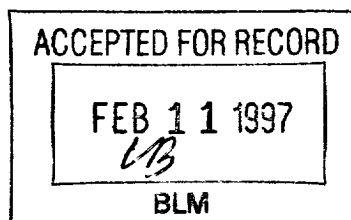

Spudded this well on 1/11/97 at 1430 hrs and drld a 12 1/4" hole to 1091'. On 1/14/97 ran 28 jts 8 5/8" 24# J-55 ST&C csg, set at 1090'. Cemented w/300 sx lite "C" + 200 sx Class "C". Circ'd 96 sxs cmt.

Drld 7 7/8" hole and reached TD 2600' on 1/17/97 at 1030 hrs. Schlumberger ran LDT/CNL/DLL/MSFL/GR logs. Ran 61 jts 5 1/2" 15.5# J-55 LT&C csg, set at 2599'. Cemented w/150 sx lite "C" + 325 sx Class "C". Circ'd 84 sxs cmt.

Released rig at 2330 hrs 1/18/97. WOCU.
