

Spudded this well on 4/11/97 at 1400 hrs and drld a 12 1/4" hole to 1071'. On 4/13/97 ran 27 jts 8 5/8" 24# J-55 ST&C csg, set at 1070'. Cemented w/300 sx lite "C" + 200 sx Class "C". Circ'd 48 sxs cmt.

Drld 7 7/8" hole and reached TD 2550' on 4/16/97 at 2400 hrs. Schlumberger ran LDT/CNL/DLL/MSFL/GR logs. Ran 61 jts 5 1/2" 15.5# J-55 LT&C csg, set at 2549'. Cemented w/225 sx lite "C" + 250 sx Class "C". Circ'd 29 sxs cmt.

Released rig at 2330 hrs 4/17/97. WOCU.
