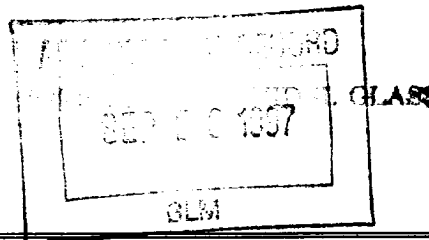

Spudded this well on 9/10/97 at 1900 hrs and drld a 12 1/4" hole to 1082'. On 9/12/97 ran 27 jts 8 5/8" 24# J-55 ST&C csg, set at 1081'. Cemented w/350 sx lite "C" + 300 sx Class "C". 4 sxs of cmt returned to surface.

Drld 7 7/8" hole and reached TD 2600' on 9/16/97 at 0630 hrs. Schlumberger ran LDT/CNL/DLL/MSFL/GR logs. Ran 57 jts 5 1/2" 15.5# J-55 LT&C csg, set at 2599'. Cemented w/225 sx lite "C" + 375 sx Class "C". Cmt did not circ.-est'd TOC @ 500'.

Released rig at 1830 hrs 9/18/97. WOCU.
