Drld 7 7/8" hole and reached TD 2500' on 7/6/97 at 2030 hrs. Schlumberger ran LDT/CNL/DLL/MSFL/GR logs. Ran 54 jts 5 1/2" 15.5# J-55 LT&C csg, set at 2499'. Cemented w/225 sx lite "C" + 250 sx Class "C". Circ'd 33 sxs cmt.
