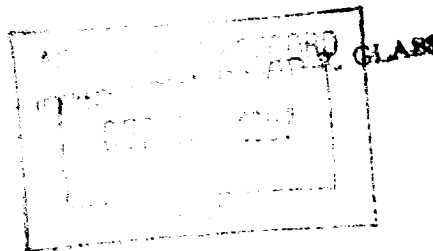

Spudded this well on 9/9/97 at 1830 hrs and drld a 12 1/4" hole to 1177'. On 4/7/97 ran 29 jts 8 5/8" 24# J-55 ST&C csg, set at 1176'. Cemented w/100 sx lite "C" + 350 sx Class "C". 116 sxs of cmt returned to surface.

Drld 7 7/8" hole and reached TD 2750' on 9/15/97 at 1030 hrs. Schlumberger ran LDT/CNL/DLL/MSFL/GR logs. Ran 61 jts 5 1/2" 15.5# J-55 LT&C csg, set at 2707'. Cemented w/275 sx lite "C" + 325 sx Class "C". Circ'd 123 sxs cmt.

Released rig at 1030 hrs 9/16/97. WOCU.
