Drld 7 7/8" hole and reached TD 2650' on 11/22/97 at 0130 hrs. Schlumberger ran LDT/CNL/DLL/MSFL/GR logs. Ran 62 jts 5 1/2" 15.5# J-55 LT&C csg, set at 2649'. Cemented w/250 sx lite "C" + 300 sx Class "C". Circ'd 22 sxs cmt.
