Drld 7 7/8" hole and reached TD 2700' on 12/5/97 at 2200 hrs. Schlumberger ran LDT/CNL/DLL/MSFL/GR logs. Ran 62 jts 5 1/2" 15.5# J-55 LT&C csg, set at 2699'. Cemented w/200 sx lite "C" + 325 sx Class "C". Circ'd 48 sxs cmt.
