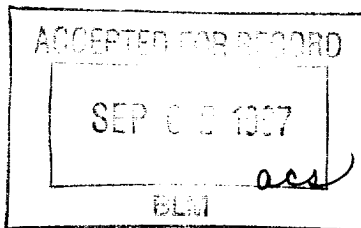

Spudded this well on 6/13/97 at 1800 hrs and drld a 12 1/4" hole to 1087'. On 8/15/97 ran 27 jts 8 5/8" 24# J-55 ST&C csg, set at 1086'. Cemented w/300 sx lite "C" + 200 sx Class "C". Circ'd 63 sxs cmt.

Drld 7 7/8" hole and reached TD 2604' on 8/18/97 at 1745 hrs. Schlumberger ran LDT/CNL/DLL/MSFL/GR logs. Ran 57 jts 5 1/2" 15.5# J-55 LT&C csg, set at 2599'. Cemented w/225 sx lite "C" + 250 sx Class "C". Circ'd 54 sxs cmt.

Released rig at 0800 hrs 8/19/97. WOCU.
