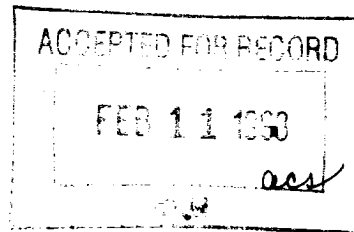

Spudded this well on 1/22/98 at 1100 hrs and drld a 12 1/4" hole to 1170'. On 1/23/98 ran 27 jts 8 5/8" 24# J-55 ST&C csg, set at 1169'. Cemented w/100 sx lite "C" + 350 sx Class "C". 13 sxs of cmt returned to surface.

Drld 7 7/8" hole and reached TD 2750' on 1/27/98 at 0500 hrs. Schlumberger ran LDT/CNL/DLL/MSFL/GR logs. Ran 64 jts 5 1/2" 15.5# J-55 LT&C csg, set at 2749'. Cemented w/250 sx lite "C" + 350 sx Class "C". Circ'd 46 sxs cmt.

Released rig at 0030 hrs 1/28/98. WOCU.
