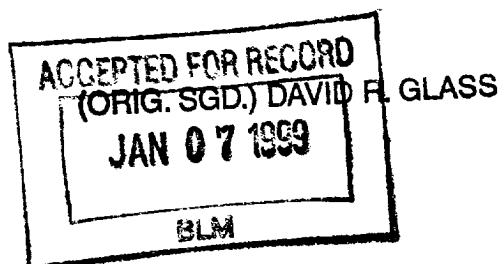

Spud well on 12/4/98 at 2230 hrs and drld a 12 1/4" hole to 1136'. On 12/6/98 ran 26 jts 8 5/8" 24# J-55 8RD csg, set @ 1135'; cemented w/ 650 sx Class "C". 60 sx cmt returned to surface.

Drld 7 7/8" hole and reached TD 3597' on 12/11/98 at 2400 hrs. Schlumberger ran LDT/CNL/DLL/MSFL/GR logs. Ran 83 jts 5 1/2" 15.5# J-55 8RD csg, set @ 3596'. Cemented w/ 702 sx Class "C". 45 sx cmt returned to surface.

Released rig at 2330 hrs 12/12/98. WOCU.
