7/11/02 Set CIBP at 9020' with 35' cement on top. Perf Atoka sands 8794'-8798' with 6 SPF (24 holes).
7/12/02-7/14/02 Break down perfs with 5 bbls of 7-1/2% Morrow acid.
7/22/02 Attempt to frac Atoka perfs 8794'-8798'. Well started circulating around 4-1/2 x 8-5/8 annulus. Start testing casing. Found hole in casing between 5244' and 5306'.
7/24/02 Squeeze hole in casing with 400 sx of 35/65 Dowell lite and 200 sx H with fluid loss. Set packer at 8464'.
7/31/02 Frac Atoka perfs 8794'-8798' with 19,000 gals of 40# WF CMHPG, 65Q CO2 foam and 38,000# of Acfrac black sand. Put 34,300# of sand in formation and left 23 sx in tubing and wellbore.
