Devon Energy Corporation (Nevada) plans to perforate and stimulate the San Andres and downhole commingle with the Yeso as follows: TOH w/ rods & pump. ND wellhead, NU BOP. TOH w/ tbg. PU CIBP & TIH on tbg, set CIBP @ ±3000'. Test CIBP to 1000 psi. Perf San Andres @ 2743'-2872'. Acidize San Andres. Frac down csg. TIH w/ RBP on tbg & set @ ±2600'. Test RBP to 1000 psi. Perf San Andres @ 2000'-2423'. Acidize & frac San Andres down csg. Retrieve RBP. Run pumping equipment & pump test until production stabilizes. After well pumps down, drill out CIBP & commingle production from the San Andres and Yeso (currently in the process of filing a downhole commingling application with the NMOCD).
