Dear Ms. Rutelonis:

Reference is made to the following: (i) your initial application dated September 29, 1999; (ii) your telephone conversation with Mr. Michael E. Stogner, Engineer/Chief Hearing Officer with the New Mexico Oil Conservation Division ("Division") in Santa Fe on Friday, January 7, 2000; (iii) your telefaxed response of February 23, 2000 with supplemental information; and (iv) the Division's records in Santa Fe including Division Cases No. 3211, 3212, and 11966: all concerning Devon Energy Corporation's ("Devon") request for an exception to Rule 104.B (1), revised by Division Order No. R-11231, issued by the New Mexico Oil Conservation Commission in Case No. 12119 on August 12, 1999, to be applicable to both the San Andres formation of the Red Lake (Queen-Grayburg-San Andres) Pool and the Northeast Red Lake-Glorieta-Yeso Pool for Devon's proposed:

- (a) Logan "35" Federal Well No. 11 (API No. 30-015-30749) to be drilled 1310 feet from the South line and 400 feet from the East line (Unit P) of Section 35, Township 17 South, Range 27 East, NMPM, Eddy County, New Mexico; and
- (b) Logan "35" Federal Well No. 12 (API No. 30-015-30750) to be drilled 580 feet from the South line and 1030 feet from the East line (Unit P) of Section 35.

The SE/4 SE/4 (Unit P) of Section 35, being a standard 40-acre oil spacing and proration unit for both the San Andres formation of the Red Lake (Queen-Grayburg-San Andres) Pool and the Northeast Red Lake-Glorieta-Yeso Pool, is to be dedicated to these two proposed wells.

Both applications have been duly filed under the provisions of Division Rule 104.F, as revised.

By the authority granted me under the provisions of Division Rule 104.F (2), the above-described unorthodox oil well locations for both the Logan "35" Federal Well Nos. 11 and 12 within a standard 40-acre oil spacing and proration unit for the: (i) San Andres formation of the Red Lake
