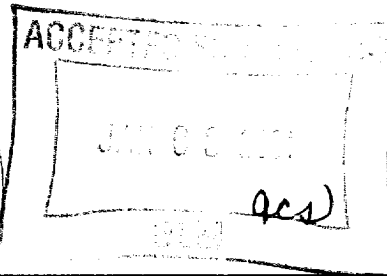
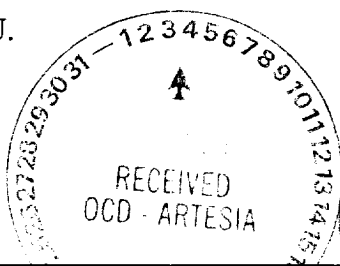

Spud well on 11/30/00 at 1400 hrs and drld an 11" hole to 1150'. On 12/1/00 ran 25 jts 8 5/8" 24# J-55 8RD STC csg, set @ 1145'; cemented w/ 100 sx "H" + 200 sx 35:65:6 + 200 sx "C". Filled backside w/ 6 1/2 - 7 yds Ready Mix. Drld 7 7/8" hole and reached TD 3800' on 12/6/00 at 1500 hrs. Schlumberger ran Platform Express Three Detector Litho-Density CNL/NGT, Azimuthal Laterolog Micro-CFL/NGT, and Natural Gamma Ray. Ran 88 jts 5 1/2" 15.5# J-55 LTC 8RD csg, set @ 3798'. Cemented w/ 250 sx 35:65:6 + 625 sx 50:50 C. 52 sx cmt returned to surface. Released rig at 2000 hrs 12/7/00. WOCU.
