Spudded a 26" hole with rat hole machine at 3:30 PM 1-5-2001. Drilled to 40'. Set 40' of 20" conductor pipe. Cemented to surface. NOTE: Notified Don Early w/BLM-Carlsbad of spud. Resumed drilling a 14-3/4" hole with rotary tools at 6:30 PM 1-7-2001.

TD 435'. Reached TD at 5:30 AM 1-7-2001. Ran 10 joints of 11-3/4" 42# H-40 (439.74') of casing set at 435'. 1-Texas Pattern notched guide shoe set at 435'. Insert float set at 392'. Cemented with 400 sacks Class C with 2% CaCl2 (yield 1.34, weight 14.8). PD 9:45 AM 1-7-2001. Bumped plug to 350#, OK. Circulated 92 sacks. WOC. Nippled up and tested to 500# for 15 minutes, OK. Drilled out at 5:00 AM 1-8-2001. WOC 19 hours and 15 minutes. Reduced hole to 11". Resumed drilling.
