Pulled rods and tubing. Cleaned out to 2,747'. Acidized with 500 gallons regular 15% acid. Ran 4-1/2" tension packer on 2-3/8" tubing. Loaded annulus with 25 gallons Nocor 439 and 100 barrels water and set packer at 2,361'. Started water injection 11-1-68. Well accepting 364 barrels water per day at 100 psi.

Instructions

Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.
