WE PROPOSE TO DRILL THIS WELL AS FOLLOWS:

OBJECTIVE: To test Premier Sand.

CASING PROGRAM: Will run approximately 330' of 8 5/8" OD casing and cement with 50 sax. If commercial production is encountered in Premier sand, will run approximately 2350' of 7" OD casing and cement with 100 sax cement.

DRILLING OPERATIONS TO COMMENCE: On or about Sept. 2, 1956 with a company owned National Machine.

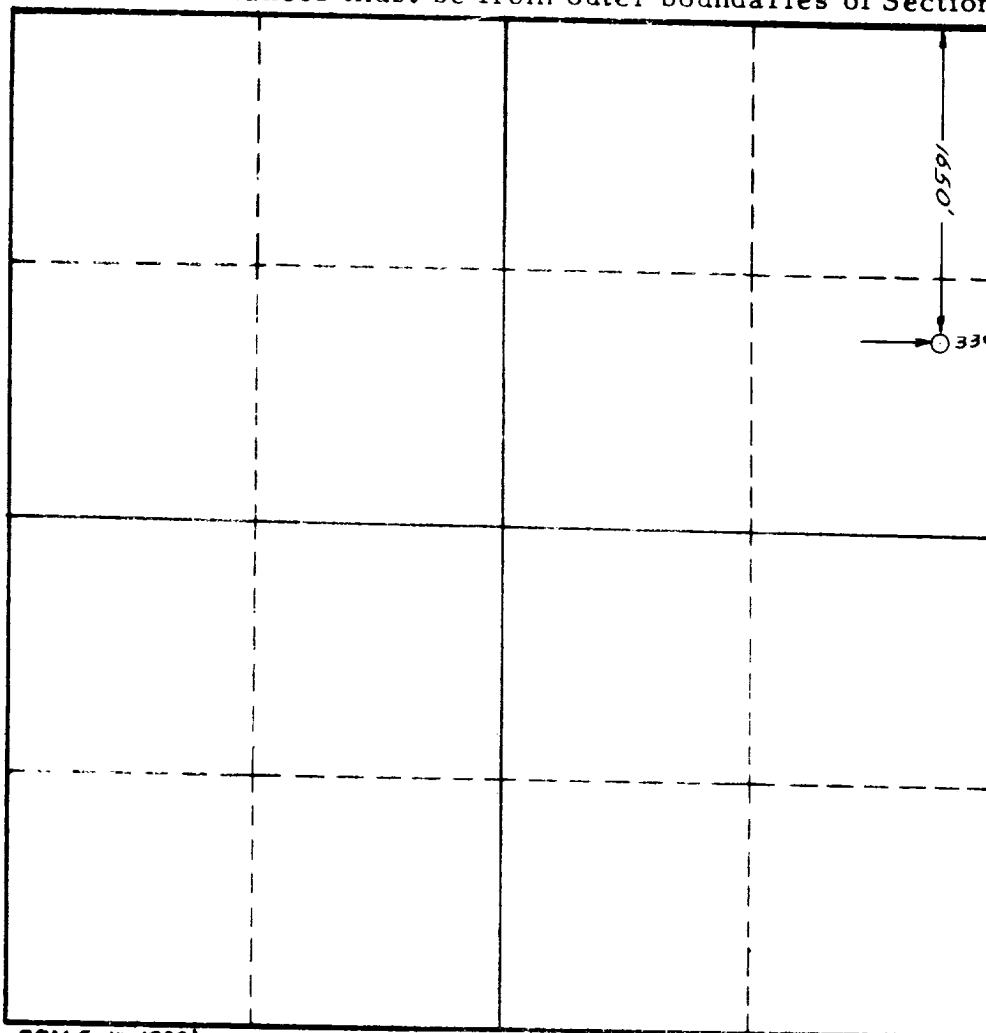
