DETAILS OF WORK

On Sept. 3, 1956, we ran 296' of 8 5/8" OD 24# & 28# 8rd thrd. casing to 302 and cemented with 50 sac Alamo cement.
After allowing to stand cemented for 72 hours, we drilled plug, bailed hole down and re-ran bailer.
As Shut-off proved complete drilling was resumed.
