Propose to pressure test 4-1/2" casing, drill cement & circulate hole clean to TD of 2621' GL, acidize with 1000 gallons 15% NE acid, frac with 10,000 gallons brine water & 10,000# sand @ 30 BPM, place well on production. Operations will commence on or about November 14, 1969.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.
