1. Pulled rods and tubing. Moved off pulling unit.
2. Perforated at 2247' - 2506' w/20 3/8" jets.*
Set retrievable bridge plug and wire line at 2558'
3. Frac down csg. w/50,000 gals. gelled water and 75,000# 20-40 sand. Overflushed w/10BW.
4. Shut-in over night.
5. Bled off pressure, ran tbg. w/retrievable head and recovered bridge plug.
6. Ran tbg. and rods and put on pump.
