Knocked off and pulled 5 1/2" casing from 550'. A 10 sx. cement plug was placed at TD 877', 10 sx. plug at 570' to approx. 540'; 10 sx. at 490' to approx. 460' and 10 sx. at 335' to approx. 305' with mud separating plugs. A cement cap and marker placed at surface. Filling of pit and cleaning of location was not done until March 17, 1960. Ready for inspection.
