DETAILS OF WORK

WE PROPOSE TO DRILL THIS WELL AS FOLLOWS:

OBJECTIVE: Grayburg-Jackson Zone.

TOTAL DEPTH: Approximately 3010'.

CASING PROGRAM: Salt String - Will set approximately 380' of 8-5/8" OD casing at top of salt and cement with 50 sacks of cement preceded by heavy mud to surface.

Production String - Will set approximately 2730' of 7" OD casing and cement with 100 sacks of cement preceded by heavy mud to surface.

ACIDIZING PROGRAM: To be submitted at a later date.

DRILLING OPERATIONS TO COMMENCE: On or about June 6, 1950.

REMARKS: This unorthodox location was authorized under NMOCC Order No. R-7 and if completed as a producing well will be produced in accordance with NMOCC Order No. 302.

I understand that this plan of work must receive approval in writing by the Geological Survey before operations may be commenced.
