DETAILS OF WORK

On 3-4-51 we ran 482' of mixed new and used 8-5/8", 24# and 28#, 8rd thrd, seamless casing to total depth 486' and cemented with 50 sacks of cement preceded by heavy mud to surface.

After standing cemented for 72 hours plug was drilled and water shut-off tested by bailing method. As water shut-off was not secured casing was recemented with 25 sacks of cement.

After standing cemented for 48 hours plug was drilled and water shut-off tested satisfactorily by the bailing method.

Cementing operations performed by Denton Oil Well Cementing Company.

I understand that this plan of work must receive approval in writing by the Geological Survey before operations may be commenced.
