OBJECTIVE: Grayburg-Jackson Zone.

CASING PROGRAM: Salt String - will set approximately 385' of 8-5/8" OD casing and cement with 50 sacks cement preceded by heavy mud to surface.

Production String - will set approximately 2880' of 7" OD casing and cement with 100 sacks cement preceded by heavy mud to surface.

ACIDIZING PROGRAM: To be determined and submitted at a later date.

METHOD OF DRILLING: Cable-tools.

DRILLING OPERATIONS TO COMMENCE: On or about April 5, 1950, with a company owned National Machine.

REMARKS: This unorthodox location approved by NMCC Order No. B-7.
