**B. L. McFarland, Inc. spudded 11" hole 9:30 p.m. 11-16-60.**

Ran 30 joints, 1202', 8-5/8" OD J-55 21# casing. Set and cemented at 1214' with a total of 325 sacks. One hundred sacks Trinity Lite Wt. w/25# Gilsomite & 2# Tuff Plug per sack followed with 225 sx Regular Neat w/2% Gel. Plug at 1171'. Maximum pressure 225#. Cement did not circulate. WOC 8 hours. Cemented with 100 sx Reg Neat with 4% Gel outside 8-5/8" casing to surface & circulated out approx. 25 sx. Job complete 11:45 p.m. 11-20-60.

After waiting on cement over 30 hours, tested 8-5/8" casing with 1000 psi for 30 minutes. No drop. Drilled plug and tested below casing shoe with 1000 psi for 30 minutes. No drop in pressure.
