DETAILS OF WORK

We propose to drill, with Rotary Rig, the Leonard Federal No. 7 well as follows:

10 3/4" hole to approximately 800' -- 8 5/8" surface casing with approximately 300 sacks cement.

7 7/8" hole to approximately 6400' -- 5 1/2" production casing with approximately 425 sacks cement.

Run Gamma Ray-Neutron and Laterolog, perforate and acidize.

I understand that this plan of work must receive approval in writing by the Geological Survey before operations may be commenced.

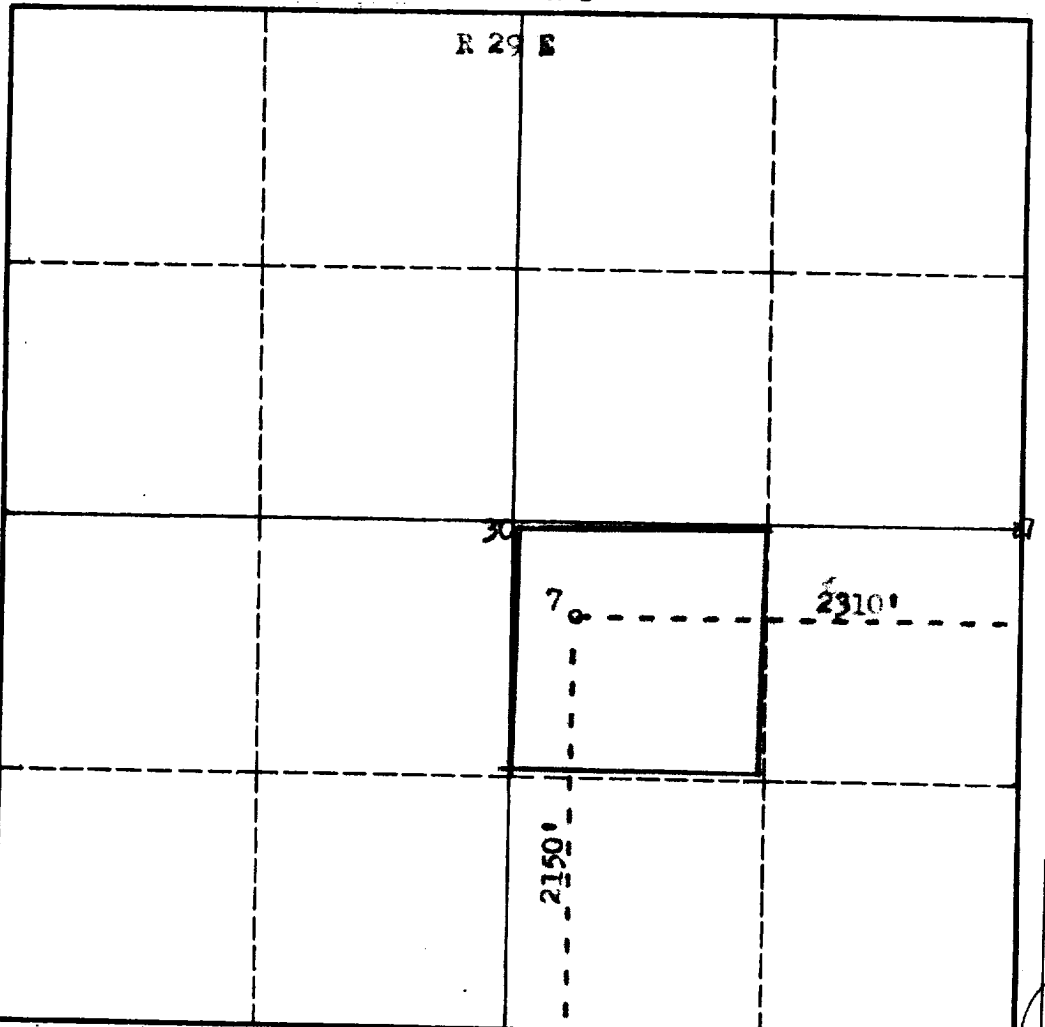
