FULL DETAILS OF PROPOSED PLAN OF WORK
(FOLLOW INSTRUCTIONS IN THE RULES AND REGULATIONS)

We propose to plug this well as follows:

We will fill the hole with mud from total depth of 2740 back to 2650 and set a bridge and plug of 5 sacks of cement ~~mix~~ at that point. Then we will fill the hole with mud to the base of the salt and set a plug of 5 sacks of cement then fill to the top of the salt and set another plug of 5 sacks of cement. Then we will knock off the 8 5/8" casing which is cemented 390 ft. and set a plug of 5 sacks of cement in the top of the pipe left in the hole. Then we will fill the hole to the surface with mud, cement the cellar and put up regulation marker.
