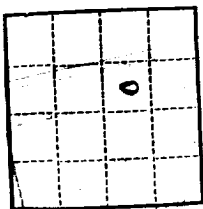

DETAILS OF WORK

We intend to drill the above well with cable tools to a depth of 3050'.
We will run 8 5/8" second hand 24# seamless surface casing to approximately 350' and cement with 75 to 100 sacks neat cement for surface water shut off and will run 5 1/2" new 14# seamless casing for production string and cement with 125 sacks neat cement.
Run Gamma-Ray Neutron log, perforate and Sand-oil frac indicated producing zones.

I understand that this plan of work must receive approval in writing by the Geological Survey before operations may be commenced.

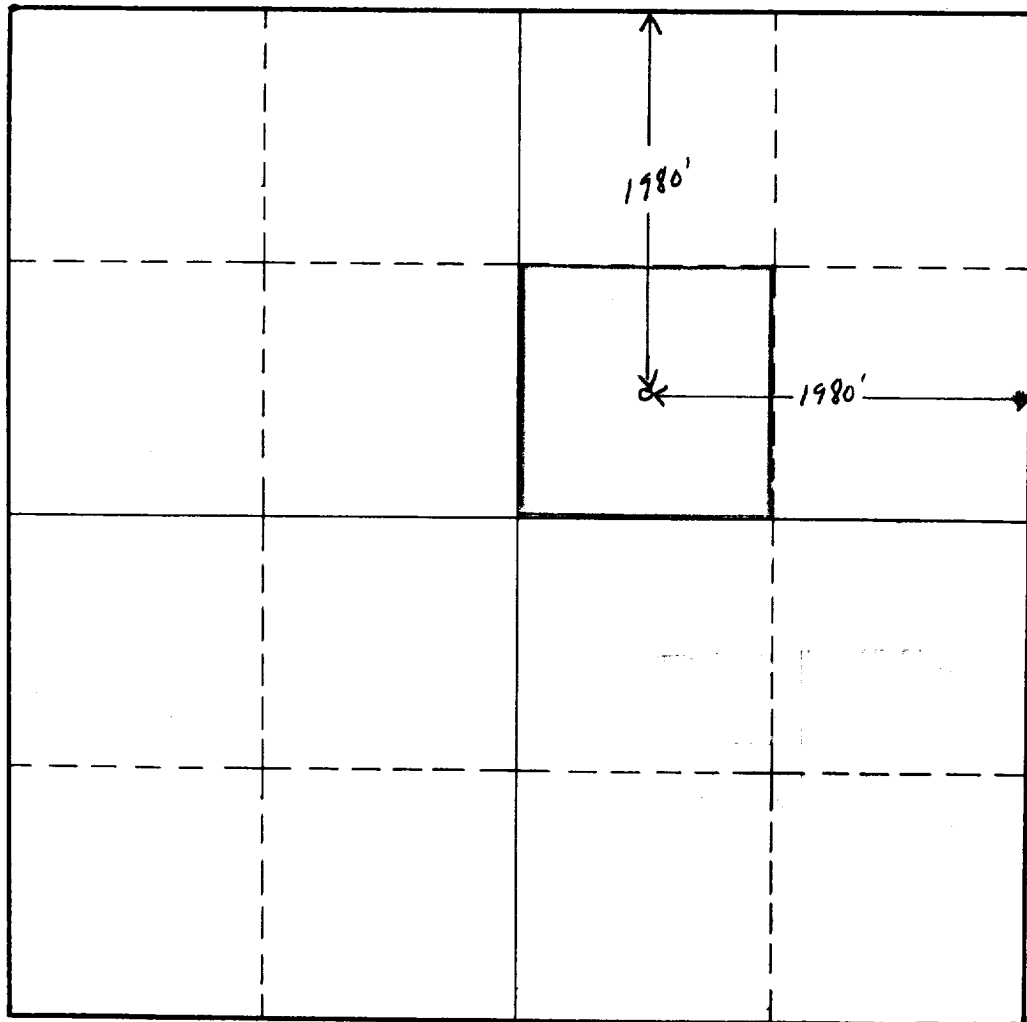
