On July 29, 1970, this well was fraced down 5½" casing with 1000# L-35 Gypban, 500 gallons mud acid, 1,000 gallons L-42 solution, 30,000 gallons Radi-Frac and 35,000# 10-20 sand. Treated at 32 BPM at 3200 psi. Treatment screened out after 32,000# sand in formation. Back flowed, then finished treatment. Before treatment, well produced 1 barrel of oil per day. Production after treatment has levelled off at 7 BOPD plus 1½BW.
