In accordance with our previous proposal for remedial work, the following work was performed: Perforated 5½" casing at 2980-86 with 10 holes and at 2916-30 with 12 holes. Ran 2-7/8" O.D. tubing with Halliburton straddle packers set at 3064, 2994, 2938 and 2901. On August 7, 1968, treated as follows:

3173-83 acidized with 6 barrels, fraced with 3,000 gallons jelled water with 3,000# sand. 16 BPM at 3800 psi.

3044-56 and 3026-32 acidized with 500 gallons, fraced with 10,000 gallons jelled water with 10,000# sand. 17.4 BPM at 3500 psi.

2980-86 acidized with 3 barrels, unable to frac at 4,000 psi.

2916-30 acidized with 2 barrels. Unable to frac at 4,000 psi.

Before treatment, well pumped 4 BO + 1 BWPD. After treatment, well pumped 4 BO + 9 BWPD (including load water). Treatment was unsuccessful.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.

Item 4: If there are no applicable State requirements, locations on Federal or Indian land should be described in accordance with Federal requirements. Consult local State or Federal office for specific instructions.
