DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED

The 8 1/4" casing was set at 548' in the Anhydrite and cemented with 50 sacks of cement. After allowing the cement to set 72 hours the plug was drilled and test for water shut-off was made and was found to be satisfactory. The plug was drilled on July 11, 1942. The information was taken from the tour sheets of Brewer Drilling Co., Artesia, New Mexico, the drilling contractor.
