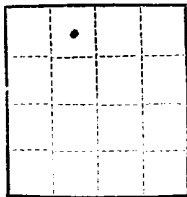

DETAILS OF WORK

This well was plugged and abandoned 11/15/1955. work done in the following manner: hole filled with mud from total dept. to or near bottom of Oil string where there was a 15 sack cement plug placed 7" O.D. casing parted pulling 847' leaving in hole 1883' hole filled with mud placing a 25 sack cement plug at casing stub. fill hole with mud to or near bottom of 10" surface casing placing a 20 sack cement plug at casing shoe. parted 10" surface casing pulling 205' leaving in hole 375' hole filled with mud set 10 sack plug at stub of 10" hole filled with dry dirt placing 4" regulation marker.
