This well will probably be reactivated in about 90 days, as soon as Texaco makes disposition of surplus equipment on the Square Lake 30 Unit.

Instructions

Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.
