

DETAILS OF WORK

We propose to drill a well at the above location to test through the Lovington sand of the San Andrea section.

We will run approximately 550 feet of 8 5/8" surface casing and cement same with 50 sacks. We will run approximately 2125 feet of 7" oil water string pulling same when the oil string is cemented. We will run an oil string of 4 1/2" casing to total depth and cement with 100 sacks of cement then perforate the sections as determined by the electric log and complete well.

I understand that this plan of work must receive approval in writing by the Geological Survey before operations may be commenced.
