This well was temporarily abandoned in September 1970 because of being non-commercial. We are requesting approval to continue this T.A. status for an additional year for the following reasons:

Since our last request for an extension, made Oct. 17, 1974, additional drilling has been done in Section 9-17S-30E. On Dec. 27, 1974, Armer Oil Company completed their Arco Federal #5, located 560' from the north and 1980' from the west lines of Section 9. Their #6 well, located 330' from the north and 1980' from the east lines was completed on Jan. 24, 1975. General American completed their Parke "G" #1, located 1980' from the north and 660' from the west lines, on April 5, 1975.

The additional year extension which we are requesting is needed to evaluate these well performances. Consideration will then be given to additional drilling on the Gissler "B" lease.
