This Unit water injection well failed the most recent NMOCD mechanical integrity test. We now propose to determine the source of the failure. Once found, we will do what is necessary for the well to pass the mechanical integrity test and to return this well to an active Unit water injection status. This may be a cement squeeze for a hole in the casing that is deep or replacement of the bad joint if the hole is near the surface.
