Run 7" Halliburton BM straddle packers, on 2 7/8" tubing, & set at 2417 & 2574.

Frased open hole 2863-3241 (Jackson Zone) with 60,000 gallons of NF 40 galled water & 36,000 #s of 20-40 sand. Used 400 #s rock salt & 250 #s of mothballs in three plugging stages. Max. press. 3000 psi, avg. inj. rate was 14 BPM.

Frased perforations 2492½-2513 (Lone Hills) with 22,500 BK gallons of NF-40 galled water, and 30,000 #s of 20-40 sand. Max. press. was 2700 psi, avg. inj. rate was 18 BPM.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.
