On 11-15-72 we ran 2-1/2" tubing packer and bridge plug and fraced Lower San Andres perfs. from 3282'-86' and 3330'-34' with 30,000# sand and 30,000 gal. gelled water. We also acidized Hobbs Vac. perfs. 2784'-88' with 2500 gals. 15% HCC acid.

On 11-16-72 started to treat Metex perfs. from 2611-17' and 2641'-44' and communicated with Loco Hills perfs. at 2488'-98' moved packer above Loco Hills perfs. and treated both sets of perfs. with 20,000# sand and 20,000 gallons gelled water.

11-17-72 Placed well back on pump.

This well was treated in lower sections only when deepened in July and tested. The above treatments were approved on original application to Deepen and Complete dated 4-28-72.

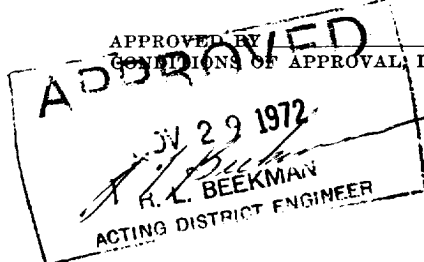

Instructions

Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.

Item 4: If there are no applicable State requirements, locations on Federal or Indian land should be described in accordance with Federal requirements. Consult local State or Federal office for specific instructions.
