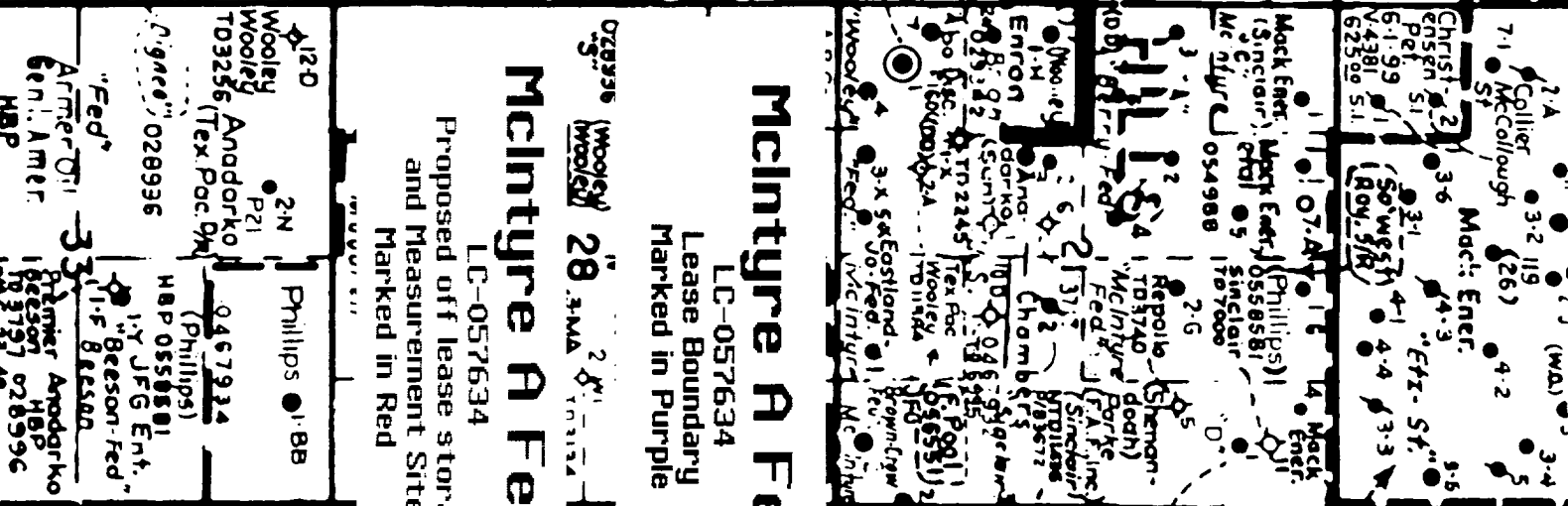
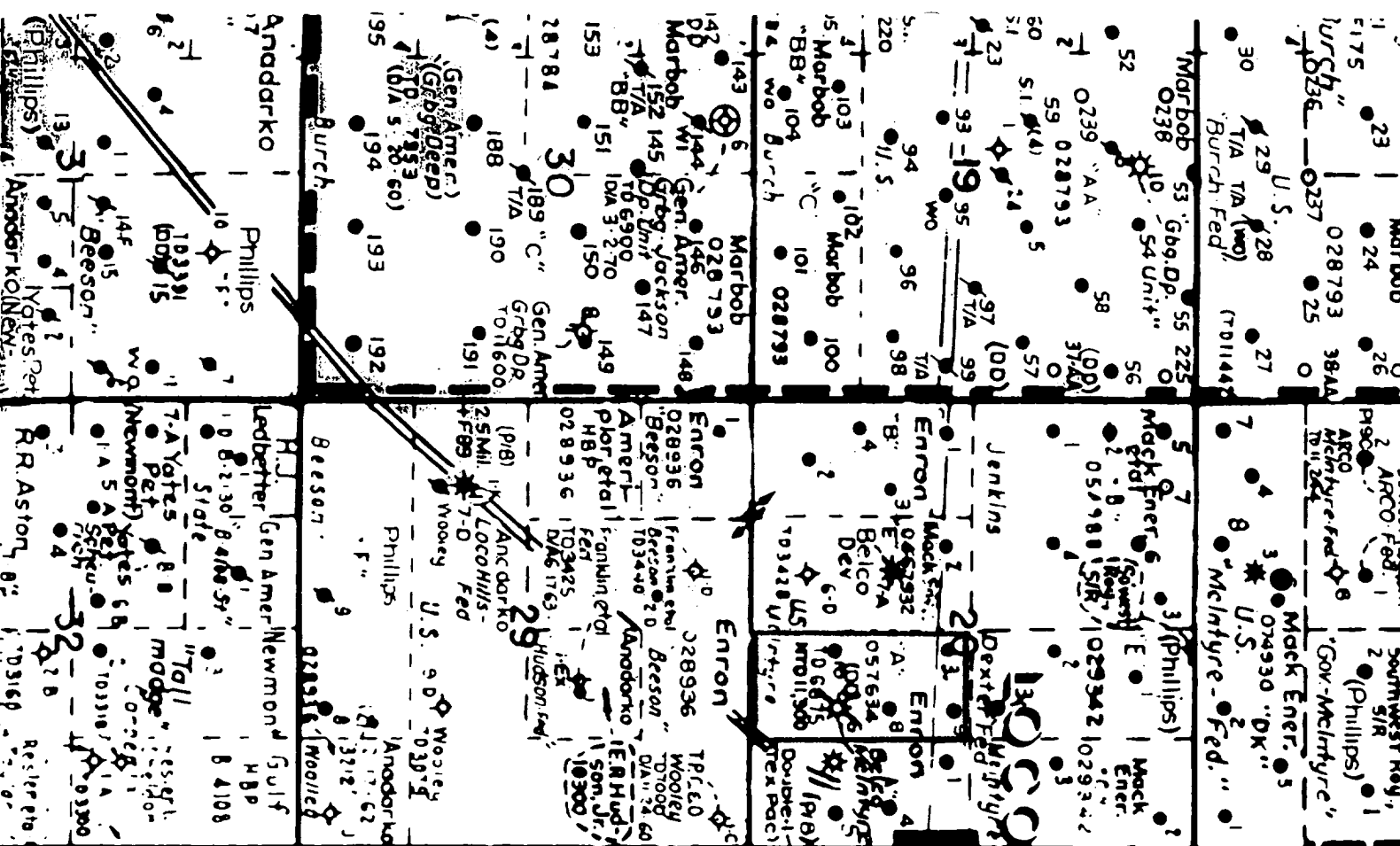
Lease Boundary

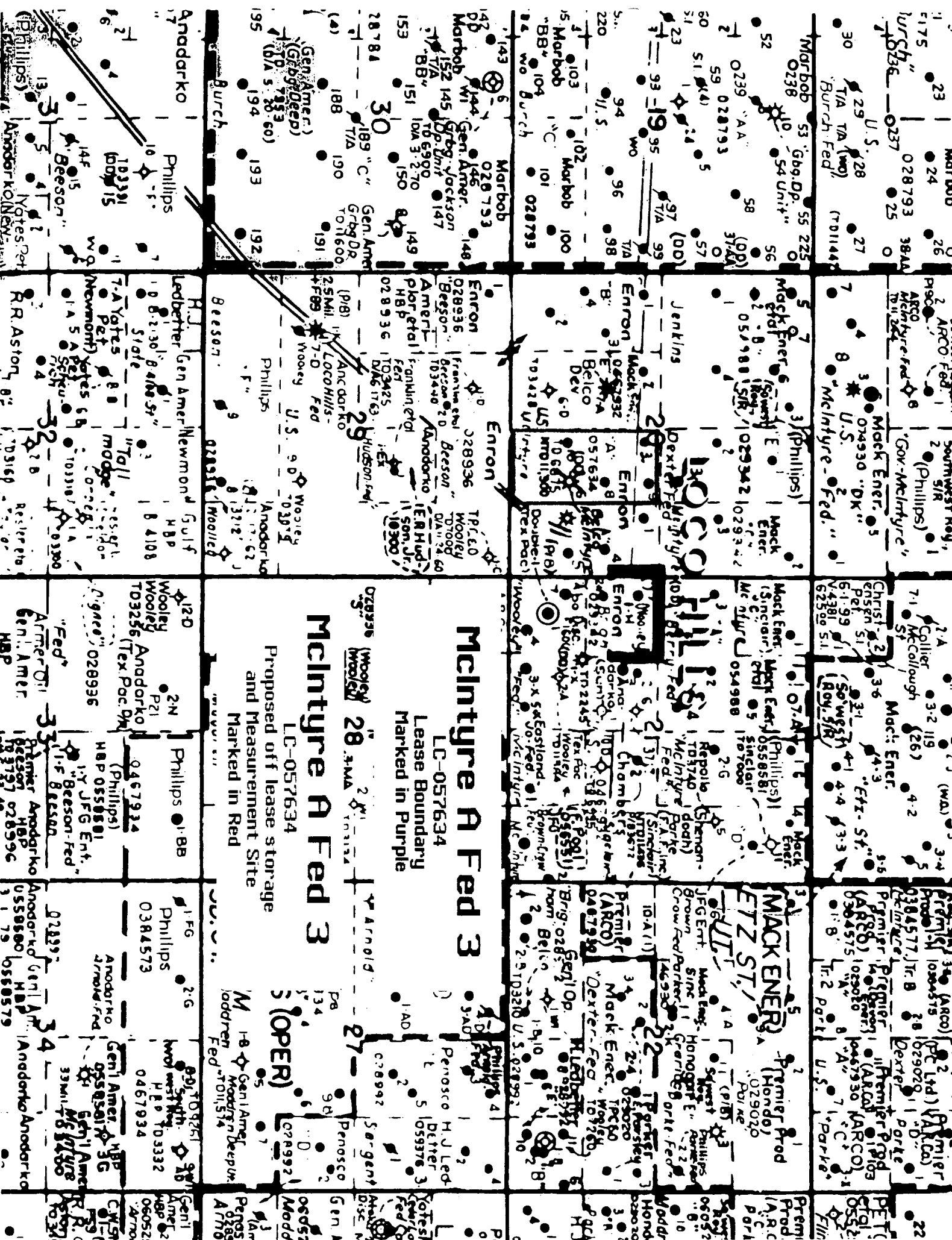

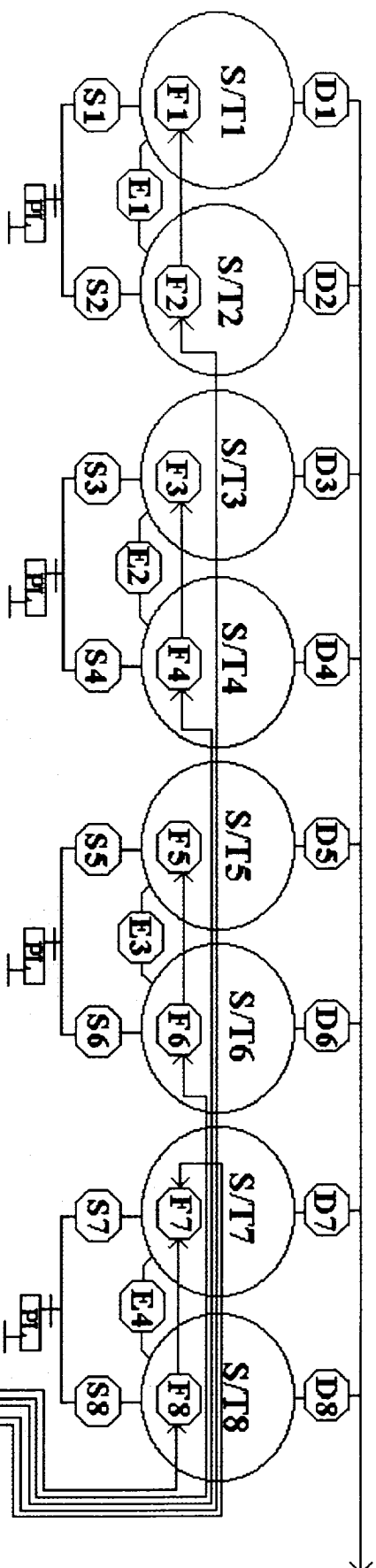
