The Above wells on this lease have been producing since 1954 and before. The wells produce in such small volumes (less than 18 BBL of oil per month and less than 12 BBL of water per month) All Production goes into a single 300 BBL stock tank. When the volume is enough for an oil sale, CAMERON contracts with a water hauling co. to drain the produced water from the stock tank and disposes of this water at Locohills water disposal located less than 1 mile north of Locohills on County Road 217, in the SW 1/4 of Sec. 16 T. 17S R. 30E permit # R08113. Due to limited economics CAMERON is requesting approval for this method of water disposal.
