We request approval to drill Gissler 11-B to approximately 7,050 feet to test the Abo. We propose to set 1,350 feet of 8-5/8" 24#, cementing to surface, and propose to set 4-1/2" casing on bottom and cement with 700 sacks. The well will be drilled with rotary by Yates Brothers Drilling Company, Artesia, New Mexico.

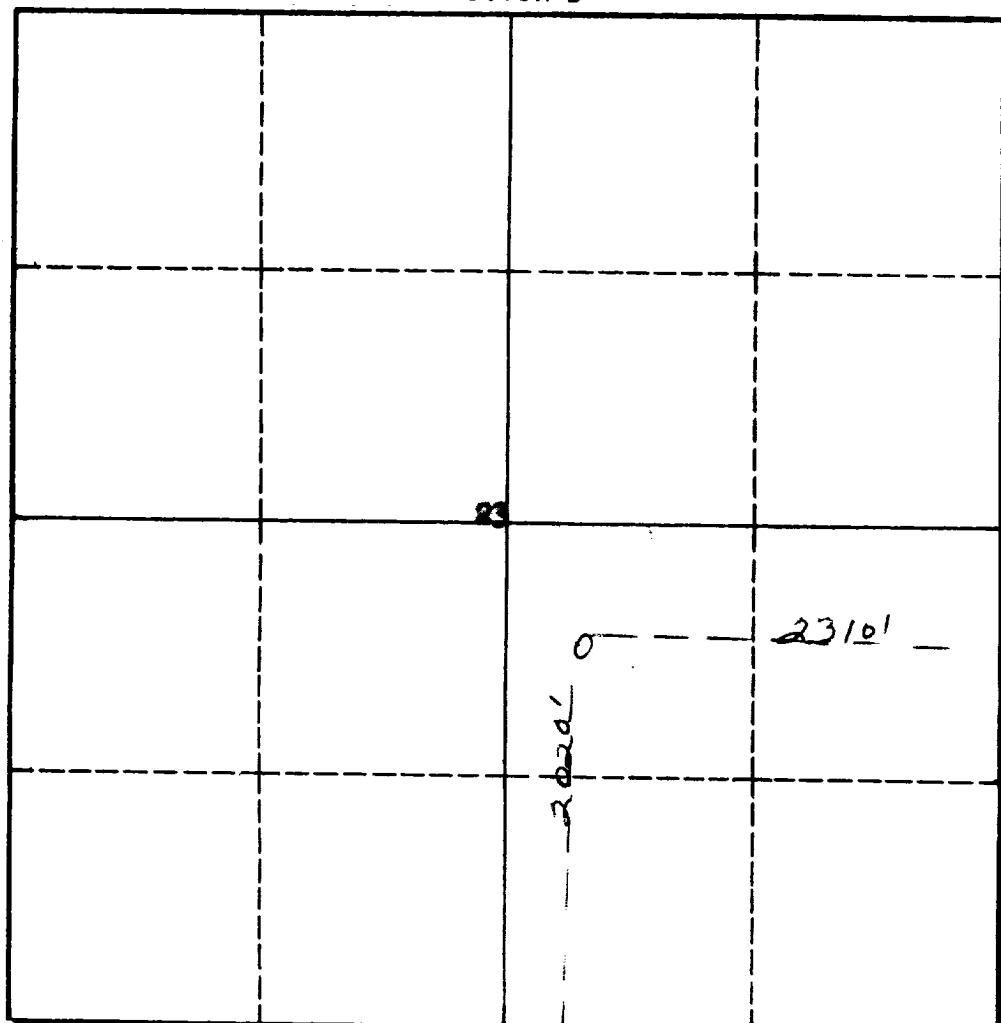
