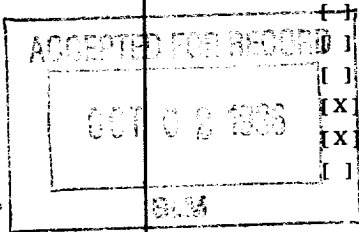

7/16/96 Called Joe Lara to confirm our desire to perforate and stimulate an additional Grayburg zone(2873'-2936') as part of our May 1996 completion in this zone. This would be reported on a new 3160-5 as soon as work is completed.

8/5/96 MIRU derrick, installed BOP, released packer @ 2857', POOH, GIH w/bailer, clean out frac sand from 3065'-3125', set 4 1/2" RBP @ 2950' & pkr @ 2945', pressure plug to 2000#, held ok. Pull tbg & pkr. 8/6 Perforate 4 1/2" liner w/3 1/8" casing gun @ 2873'-76',2881'-83',2902'-04', 2918'-20' & 2932'-36' @ 1SPF total of 18 shots. Set pkr @ 2828', broke formation @ 2200 psi. & pumped 1000 gals 15% HCL @ 3 1/2 BPM @ 1900 PSI, dropped 27 balls, good action. Displaced HCL @ avg of 1900 #, & max of 2700 #. ISIP 1300# SITP 325# after 14 hrs. Fraced perforated zone 2873'-2936' w/total 26,000 gals SPECTRA FRAC 3000 w/62,000# 20/40 sand, ISIP 1625', SITP 1563# in 15 mins. 8/8-20 Swab test recovered 216 BLW & avg. 37 BOPD over 6 days.

8/21-23 MIRU derrick,GIH w/BP catcher, began to circulate sand off BP, got returns between 7" csg & surface csg. POOH w/tubing, GIH w/7" cup type RBP & tension pkr, set BP @ 2804', tested to 1000# ok, worked up hole to locate possible leaks. 8/27 Dug out out cellar, replaced bad 7" csg nipple. 9/3-4 MIRU , installed 7" x 4 1/2" braden head, NU BOP ran catcher to 2765', loaded hole w/2% KCL, pressured 7" csg to 400# for 25 mins, no leak. Released pressure, lowered tubing to 2804', no BP found, did find BP @ 2873' on top of 4 1/2" liner, released BP & POOH, ND BOP & removed braden head, ran bailer, pumped 25 bbls 2% KCL down 7" casing, pumped approx. 40' frac sand off 4 1/2" BP @ 2950', released RBP, POOH. GIH w/3067' 2 3/8"tbg, pump & rods, installed 114 pumping unit, put well to pumping 4:00 PM 9/4/96.

NOTE:No additional 4 1/2" casing was required as requested in our proposal of 8/29/96 Notice of Intent filing to Mr. Adam Solemh.
