On May 12, 1970, this well was acidized with 4,000 gallons of 28% acid with 12 gallons of W-35 and 140# of J-150 fluid loss control. Treating pressure was 2450 psi. maximum which decreased to vacuum. Rate was 3 BPM. After treatment, well pumped 36 barrels of oil plus 40 barrels of water. Before treatment, well pumped 9 barrels of oil plus 20 barrels of water per day.

Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.
