We propose to convert this well to water injection. Water produced from the Abo formation will be disposed into the Abo formation in the interval from 6945' to 7028'. 2-3/8" O.D. upset tubing internally coated with plastic will be run and a tension packer will be set in 4 1/2" casing at approximately 6850'. Injection will be down tubing.

Instructions
